Following pressure from the community council, RWE has agreed to hold an open afternoon/evening at Bro Derfel Community Hall on the 2nd of December between 3.30pm and 7pm. To follow there will be a public meeting between 7 and 8 p.m. chaired by the community council where anyone will have the opportunity to ask questions to the RWE representatives. A translation service will be available at the meeting and there will be an opportunity to ask questions through the medium of Welsh or English. RWE have promised to send us posters to promote the event which we will distribute.
